- II. Secretary's Report: Minutes from the September meeting were presented. No changes or corrections. Motion to approve the minutes Stephanie Longie; second Lacey Eiseman. Motion passed.
- III. Treasurer's Report: The bank account has a balance of \$5,762.87. A deposit of \$1,220 was made from the teacher's jeans day. Motion to approve the minutes Mandy Maxon; second Jessica Moch. Motion passed.
- IV. Introductions
 - a. Kris Heiple 8th grade counselor. Speaking about MTSS-B (Multi-Tier System Support Behavior) 3 Tier System.
 - i. Tier 1: Supports for ALL students. Some examples are celebrations, ROAR cards, new ROAR posters throughout school
 - ii. Tier 2: Support for SOME students. Some examples are CICO (Check-in/Check-out) system, individual support. Approx. 100 students in Tier 2.
 - iii. Tier 3: Supports for a FEW students. Tier 3 addresses significant students concerns. Approx. 100 students in Tier 3.
 - iv. MTSS-B Goals for current year
 - 1. Staff acknowledgement giving more ROAR cards
 - 2. Second step lessons
 - Track students using extra supports (nurse, student services, etc.).
 Student services secretary is tracking data of who is coming and when.
 - 4. Improve communication websites have been re-done, MTSS took over announcement boards, and have increased number of ROAR posters throughout school.
 - 5. Develop an effective Tier 2 system
 - 6. Expanding access to SBMH (school-based mental health) services.
 - a. West Central Human Services has a counselor available 1 day/week. Wachter has added 1 more day/week with a counselor from the Village Family Services. The district doesn't pay for these services, but provides the setting.
 - v. MTSS-B is looking for parent representatives to join. Committee is currently made up of teachers from each grade level and 2 counselors.
 - 1. Regular meetings take place the 3rd Thursday of each month from 7:50-9:20 a.m. Once each year there is a ½ day retreat

 - i. Mandy Maxon presents the following change to Article 4, Section 1: "There shall be a minimum of one monthly meeting of this organization during the months of September through May of the school year. The meetings shall be held onsite at the school and/or virtually during the noon hour. The dates shall be set each year by the president after consultation with the principal. Meetings can be cancelled or modified by the Executive Committee as necessary.
 - ii. Lisa Koch presents the following change to Article 4, Section 3: "The election of officers shall take place during or prior to the May meeting each year or as deemed necessary by the Executive Committee."
 - iii. Lisa Koch presents the following change to Article 6, Section 2: REMOVE "prior to the end of the treasurer's term, and transfer the books to the newly elected treasurer."
